(1) The Transportation rate decrease of 0.6574 cents/ m³ consists of an increase of 0.0117 cents / m³ in the new rate and a temporary credit of 0.6691 cents/ m³. The temporary credit, for the period July 1 to December 31, 2005, will amount to a decrease of about \$260.

(2) The Delivery to You rate decrease of 0.6562 cents/ m³ consists of a temporary credit of 0.6562 cents/ m³. The temporary credit, for the period July 1 to December 31, 2005, will amount to a decrease of about \$255.

(3) The transportation rate change includes the expiry of the temporary credit of 0.6691 cents / m³. The annual bill decrease of \$46 excludes the temporary credit in the previous Transportation to Union Gas rate.

(4) The Delivery to You rate change includes the expiry of the temporary credit of 0.6562 cents / m³. The annual bill change of \$0 excludes the temporary credit in the previous Delivery to You rate.

* Prior to July 1, 2006, your bill will combine each rate and the associated price adjustment (if applicable) on a single line.

(5) The Transportation Price Adjustment decrease of 0.9313 cents/m³ consists of an increase of 0.1525 cents/m³ in the new rate and a temporary credit of 1.0838 cents/m³. The annual bill increase of \$141.81, which appears in the table above, excludes the impact of the temporary credit. The temporary credit, for the period October 1 to December 31, 2006 will amount to a decrease of \$318.03.

(6) The Delivery Price Adjustment decrease of 0.0872 cents/m³ consists of a temporary credit of 0.0872 cents/m³. The temporary credit, for the period October 1 to December 31, 2006, will amount to a decrease of \$25.59.
