Re: UNION GAS LIMITED HUBXXX CONTRACT  
ENHANCED PARKING SERVICE AGREEMENT (HUBXXXEXX)

Dear Shipper:

This Enhanced Parking Service Agreement confirms the existence of an Interruptible Service Hub Contract (HUBXXX) (the “Contract”) between Shipper Name (“Shipper”) and Union Gas Limited (“Union”). In addition to the terms and conditions of the Contract, Shipper has requested and Union has agreed to provide an additional “Enhanced Parking Service” as described herein. All basic terms and conditions of the Contract shall be applicable to this Enhanced Parking Service, and during the term of this Enhanced Parking Service Agreement, the Contract may not be terminated by Shipper or Union, except as defined in the Default and Termination section of the General Terms & Conditions. In the event of any other discrepancy or conflict in the terms and conditions between the Contract and this Enhanced Parking Service Agreement, the terms and conditions of this Enhanced Parking Service Agreement shall supersede and take precedence over the Contract. This Enhanced Parking Service Agreement shall provide the following:

1. Union shall provide Shipper an Enhanced Parking Service (“Service”), at Dawn, for the period of Start date to End date, for a maximum quantity of Contract Quantity GJ (Contract Quantity MMBtu) (“Maximum Parked Quantity”).
2. Union, on any day, shall receive from Shipper, on an interruptible basis, up to Contract Quantity GJ/day (Contract Quantity MMBtu/day), or the maximum quantity of gas which Union determines it can accept at Dawn.
3. On any day between date and date inclusive, Union shall deliver to Shipper, up to Contract Quantity GJ/day (Contract Quantity MMBtu/day), on an interruptible basis, or the maximum quantity of gas which Union determines it can deliver at Dawn.
4. Shipper shall ensure that the balance under this agreement shall be reduced to zero (0) on or before End date. Should Shipper fail to comply with this requirement, any balance remaining shall be removed immediately from this agreement and transferred to Shipper's Balancing Account under Contract HUBxxx, and shall be subject to the associated charges required to complete the transfer. The quantities shall automatically be deemed to be in an Extension Period and shall be subject to the rates and terms as set out in Schedule “B” of HUBxxx, and the penalties as described in HUBxxx, Article 5.01 C(c).

5. Shipper agrees to pay Union for this Service herein:
- a) a demand charge of \$XXX,XXX US which shall be invoiced in number (X) equal monthly instalments of \$XX,XXX US for the months of month, year to month, year, inclusive; plus
  - b) after Union has received from Shipper and delivered to Shipper a cumulative quantity of Maximum Parked Quantity X 2 GJ (Maximum Parked Quantity X 2 MMBtu), any further quantities received by Union from Shipper or delivered by Union to Shipper pursuant to this Service, shall be charged at \$0.024 Cdn/GJ (\$0.025 Cdn/MMBtu).
6. This Enhanced Parking Service Agreement will take effect immediately.

Please acknowledge your agreement to the above terms and conditions by signing and returning both copies of this Enhanced Parking Service Agreement to **Union Gas Limited, 50 Keil Drive North, P.O. Box 2001, Chatham, ON, N7M 5M1, Attention: S&T Contracting** for execution by Union, whereby this shall then constitute a binding Agreement as between the parties.
