# New natural gas rates

The Ontario Energy Board (OEB) has approved changes to Enbridge Gas' rates effective **April 1, 2021**.

For a typical customer the total annual bill increase will be \$61.06. The total impact on your bill will depend on how much gas you use.

The OEB has approved a temporary price adjustment to reflect the difference between the amount customers paid for energy conservation programs (DSM) from Jan. 1, 2017 to Dec. 31, 2018 and the actual costs incurred. This will appear on customers' April to September bills, and for a typical Rate 01 - Union North East customer the total refund will be \$9.03.

## Delivery to You

The delivery rates that vary with consumption increased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you.

## Transportation to Enbridge

The transportation charge has increased by approximately \$0.11 per year for a typical customer due to higher costs for transporting natural gas.

## Federal Carbon Charge

The federal carbon charge has increased from 5.8700 ¢/m<sup>3</sup> to 7.8300 ¢/m<sup>3</sup>. This charge increases annually each April. ## Gas Supply Charge

The gas commodity rate increased by 0.4184 ¢/m<sup>3</sup> to 13.7598 ¢/m<sup>3</sup> based on our forecast of natural gas market prices for the next 12 months. This rate includes transportation costs to Ontario.

## Gas Price Adjustment

The gas price adjustment rate decreased by 0.3797 ¢/m<sup>3</sup> to -0.9051 ¢/m<sup>3</sup> and is in effect until March 31, 2022.

## Delivery Price Adjustment

The delivery price adjustment rate decreased by 1.7327 ¢/m<sup>3</sup> to -1.7327 ¢/m<sup>3</sup> and is in effect until Sept. 30, 2021.

## Transportation Price Adjustment

The transportation price adjustment rate increased by 0.7533 ¢/m<sup>3</sup> to -0.1792 ¢/m<sup>3</sup> and is in effect until March 31, 2022.

## Storage Charge

The storage rate increased by 0.0010 ¢/m<sup>3</sup> to 5.8116 ¢/m<sup>3</sup> to reflect the increased cost of storing natural gas.

Charges for gas used from April 1, 2021 will be calculated using the new approved rates as shown on the reverse. The annualized impact is based on a typical Rate 01 - Union North East customer who uses 2,200 m<sup>3</sup> per year.
