Seasonal Contract Demand is a Firm Service for the period identified above.

The Interruptible Contract Demand shall be subject to interruption by Union on not more than \_\_\_\_\_ days in any Contract Year. Union shall provide Customer at least \_\_\_\_\_ hours notice before interrupting this service.

The Total Contract Demand is the sum of the Firm Contract Demand, Seasonal Contract Demand and Interruptible Contract Demand.

**3. RATES FOR SERVICE**

- ii. On any Day, any Gas in excess of one hundred and three percent (103%) of the uninterrupted Total Contract Demand shall be unauthorized overrun Gas and shall be paid for at the rate specified in the Rate Schedule.
- iii. On any Day during the Contract Year, Gas usage shall be deemed as follows:
